
Key Assumptions:

- Full Year Revenue between \$1.015 billion and \$1.035 billion, up from \$1.0 billion and \$1.030 billion. Full Year Adjusted EPS between \$3.15 and \$3.25, up from \$3.05 and \$3.20.
- Adjusted Gross Margins expected to be around 57% in the back half of 2021.
- Pandemic impact ameliorates as year progresses.
- United States rebounds faster than international markets. General Surgery rebounds faster than Sports Medicine.

- The Smoke Filtration market is estimated to be at mid-single-digit penetration on a multi-billiondollar Total Addressable Market
 - AirSeal[®] is estimated to be at mid-teens penetration of its Total Addressable Market (~35% on current robotic procedures and singledigits on non-robotic procedures)






- Organic R&D continues to advance and have an impact:


- Global General Surgery products expected to grow at above-market rates for the long term, due to additional sales representatives and improving customer engagement
